## **Resolution of the Klondike ISD Board to Set Tax Rate**

*(If Maintenance and Operations Tax Revenue Will Not Exceed Previous Year)*

Date: August 28, 2023

On this date, we, the Board of Trustees of the Klondike Independent School District, hereby levy or set the tax rate on \$100 valuation for the District for the tax year 2023-2024 at a total tax rate of \$0.8097, to be assessed and collected by the duly specified assessor and collector as follows:

\$.75750 for the purpose of maintenance and operations, and

\$.0522 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.
