**(DIS)APPROVAL OF MARTIN COUNTY APPRAISAL DISTRICT'S
RESOLUTION NO. 2-2025
KLONDIKE INDEPENDENT SCHOOL DISTRICT**

WHEREAS, a quorum of the Board of Directors of the KLONDIKE INDEPENDENT SCHOOL DISTRICT (hereinafter "the Board") met in a duly posted, open and public meeting;

WHEREAS, Texas Tax Code § 6.01 mandates an appraisal district be established in each Texas county and charges it with responsibility for appraising property in the district for ad valorem tax purposes of each taxing unit that imposes such ad valorem taxes in the district;

WHEREAS, the Martin County Appraisal District (hereinafter "the Appraisal District") has its appraisal office located at 308 N. Saint Peter St., Stanton, Martin County, Texas, 79782;

WHEREAS, the Appraisal District has outgrown its current appraisal office space and requires more space to efficiently operate and conduct the Appraisal District's mission and day-to-day business;

WHEREAS, Texas Tax Code § 6.051(a) authorizes the Appraisal District's Board of Directors to have improvements or renovations constructed, as necessary, to operate the appraisal office;

WHEREAS, the Appraisal District's Board of Directors has exercised its authority under Texas Tax Code § 6.051, and seeks to have improvements constructed to improve the operations of the Appraisal District's appraisal office;

WHEREAS, the Appraisal District seeks the approval of KLONDIKE ISD, which pursuant to Texas Tax Code 6.037, is entitled to vote to approve or disapprove the construction or renovation of the Appraisal District's office,

WHEREAS, the Appraisal District's Board of Directors through its Chief Appraiser has notified the KLONDIKE ISD presiding officer of the Appraisal District's proposed action by delivering a copy of Resolution No 1-2025, together with information showing its proposed costs, or other available alternatives to this proposed action;


WHEREAS, the project budget for construction or remodeling at the appraisal office is to be no more than \$ 4,500,000;

WHEREAS, the governing body of the KLONDIKE ISD evaluated and discussed the Appraisal District's proposal to construct or renovate its appraisal office;


NOW, THEREFORE, BE IT RESOLVED BY THE KLONDIKE ISD:

THAT the Martin County Appraisal District's proposal to construct or remodel its appraisal office located at 308 N. Saint Peter St., Stanton, Martin County, Texas, 79782 is hereby APPROVED/ DENIED.
